Limited Review Report

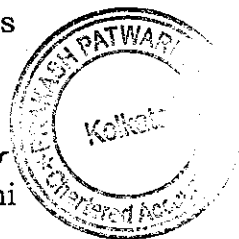

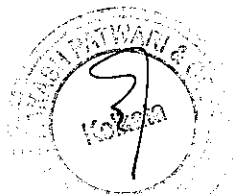
