
### Limited Review Report

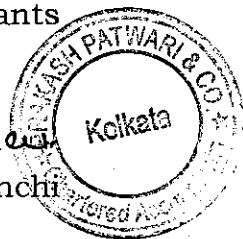
